# Multiple intracranial meningiomas and accompanying basilar artery aneurysm

Brain tumors and intracranial aneurysms rarely coexist. A case of association between multiple intracranial meningiomas and cerebral artery aneurysm is reported.

Beyin tümörlerine eşlik eden intrakranial anevrizmalar oldukça nadirdir. Çok sayıda menenjioma eşlik eden, baziler arter anevrizması bulunan 52 yaşındaki erkek olgu sunulmaktadır.

**B** rain tumors and intracranial aneurysms rarely coexist. Until now, 180 cases have been reported (1-3), accounting for an incidence rate of nearly 0.3-4 % (1). The coexistence of meningioma and intracranial aneurysms is even rarer with only 94 cases reported in the literature (1-3).

Meningioma has been the most common intracranial tumor along with aneurysm (1). While the aneurysm of other arteries along with meningioma is relatively more common, only 3 cases with basilar artery accompanied by meningioma have been reported (4). A case of coexisting basilar artery aneurysm and multiple meningiomas has been reported in the light of the relevant literature.

#### **Case report**

A 52-year-old male patient presented with headache of 5 months and vertigo attacks. The history was non-specific. He had no family history. The results of neurological examination were normal. No hypertension was detected.


The patient underwent magnetic resonance imaging (MRI). The evaluation revealed meningioma like lesions with dural tails located in the right parasagittal convexity, left petroclinoid ligament, and the olfactory groove. The extraaxially located lesions were isotense with the gray matter on T1-weighted images and slightly hyperintense on T2-weighted images and showed homogenous contrast enhancement after Gd-DTPA injection (Figure 1 a,b,c). A peritumoral edema was detected in the brain parenchyma around the lesion in the olfactory groove.

MRI also showed aneurysm in the basilary tip (Figure 1 d,e). A solitary aneurysm was detected (with cerebral angiography). It was decided to treat to aneurysm via the endovascular route using aproximal occlusion technique. The lesion in the olfactory groove was operated and pathological evaluation confirmed the diagnosis of meningioma.

## Discussion

The coexistence of meningioma and intracranial aneurysms is a rare occurrence. Only 94 cases have been reported up to date (1-3). Three of these cases were reported to be aneurysm in the basilar artery (4).

The aneurysm incidence for the whole population is 0.5 %, while it is 0.3-0.7 % among brain tumor patients. Basilar artery aneurysms are rare. About 10% of all intracranial aneurysms arise on the vertebrobasilar circulation. Five per cent arise from the basilary artery bifurcation, and the remaining 1% to 5% arise from other posterior fossa vessels (1). In one study, aneurysms were detected at a higher rate among the brain tumor patients than in the normal population (5). However also, another study reported much higher aneurysm incidence in brain tumor patients (4%), but since not all brain tumor patients could undergo four-vessel angiography, the actual incidence rate for this group of patients was considered to be even higher than the reported (1).

The advent of MR and CT angiography as well as CT scanning has raised expectations that aneurysm screening may soon become feasible. These technologies can provide detailed noninvasive images of the major cerebral arteries and thus avoid the use of the more expensive invasive intra-arterial DS angiography. Several recent studies have shown that MRA reliably detects aneurysms greater than 3 mm in diameter, an important consideration, as risk of rupture may correlate with aneurysm size. Although a negative MRA at the time of screening does not guarantee that an aneurysm is not present or will not form, the likelihood of these events is remote. Accepting these caveats, one may conclude that MRA may be a reliable screen for clinically significant cerebral aneurysm (6-8).

Literature review revealed that in order of incidence, the brain tumors accompanying aneurysm were meningioma (29.3%), glioma (27.5%), and hypophysis adenoma (20.6%) (4). In another study, the rate of meningioma was relatively much higher (44%) (5).

Meningiomas are common tumors (1). The meningioma associated symptoms observed in this coexistence are no different than those of the other meningioma cases. Furthermore, the locations preferred by meningiomas are similar (1).In all of the series, incidence rate of ipsilateral aneurysms and meningioma coexistence has been found to be higher (1). Accompanying aneurysm has been encountered in the internal (ICA), middle (MCA) and anterior (ACA) cerebral artery in order of incidence and relatively fewer in more than one artery (4). Some authors have reported marked incidence rates in MCA for convexity meningiomas and in ICA and anterior communicating artery for basal meningiomas (1). In two of the three cases with meningioma accompanied with basilar artery aneurysm, aneurysms were detected in posterior communicating artery, MCA, and other arteries. However, none of these cases had meningiomas located in the basilar artery region (4).

These tumors with high vascularity may increase the regional blood flow, which supports the dominance of ipsilateral aneurysms. However, numerous authors interpret this finding as merely coincidental (1). The authors describe a previously published case report of a patient with an enlarging ACA aneurysm after the posterior fossa meningioma removal (9).

None of the meningiomas in our case was located in the area supplied by the basilar artery, supporting previous

claims that multiple meningiomas do not result from hypervascularity. Ipsilateral location is coincidental; no secondary etiology for aneurysm was detected.

Other authors have claimed that meningiomas and aneurysms may be affected by hormonal factors and emphasized that surgical trauma to the arterial wall or invasion of the artery by the tumor and genetic factors might lead to aneurysms (1).

A probability of incidental aneurysm in the same location or a distant region in a case with brain tumor should be kept in mind and radiological evaluation (CT and/or MRI) should be performed with great scrutiny with respect to aneurysms.
